**READ:-** Guideline published on Reservation Policy by the University Grants Commission New Delhi vides Letter No. F, 1-5 / 2006 (S.T.C) dated :-25-08-2006

**Circular :-**

Universities and Principals of the affiliated colleges under this Department, Heads of recognized institutions, Heads of University Postgraduate Departments and the Professors in charge of the Postgraduate Centers run by the University are informed that as per the orders given by Government and various Statutory Bodies, it is expected that action will be taken for admission in the Institutes. In addition, as per the reservation policy prescribed by the Central /State Government, student admission and staff recruitment process in Government/ semi-Government/Grant in aid institutions as well as in self finance colleges / Institutions are only required to strictly adhere to the student reservation policy. In view of the existing provisions regarding the reserve policy, for the sake of administrative simplicity as well as for the proper understanding of the administrators / implementers, the policy regarding admission in the reserve category in the University and all the colleges affiliated to the University as well as staff recruitment should be the same in all the Institutions, and for that the Provisions are as stated below. The surveyors are therefore advised to strictly implement it.

## **STUDENTS ADMISSION:-**

- (1) Undergraduate, Postgraduate, M.Phil., Ph.D. Etc. Student admission in all the courses of the Level as per the prescribed proportion.
- (2) Exemption will have to be given subject to the rules of Central Government, UGC, various Statutory bodies in the prescribed educational qualification, age limit, experience, passing standard in entrance examination etc. for admission.
- (3) In case of non-implementation of any special provision regarding lower percentage of Scheduled Caste, Scheduled Tribe student admission, in case of unavailability of the said Students, admission will have to be given up to passing standard.
- (4) Admission procedure will have to be done separately for Scheduled Caste, Scheduled Tribe Students.
- (5) If Scheduled Caste, Scheduled Tribe students are admitted as per general merit on the basis of Their merits, except for exemption from payment of prescribed standards such as admission Fee, session fee which is applicable to them, then Scheduled Caste, Scheduled Tribe students not to be taken into account, but to be considered to have been admitted to the general level.
- (6) If the candidates of Scheduled Caste/Scheduled Tribe are not available as per the prescribed Proportion, then in the category of vacancies in Scheduled Castes/Scheduled tribes, vacancies can be admitted mutually.
- (7) If the candidates of Scheduled Caste / Scheduled Tribe are not available as per the prescribed Proportions, to be widely published in the national level newspapers.
- (8) Organizing short term coaching classes to prepare students for the admission process.
- (9) The Admission Process Committee must have one representative from either Scheduled Caste / Scheduled Tribe.

## **Staff Recruitment:-**

- (1) Separate interview procedure will have to be conducted for SC / ST candidates.
- (2) Candidates belonging to Scheduled Castes / Scheduled Tribes, if selected on the basis of merit based on their merits, shall be counted against the prescribed proportions of that category, except for exemption from payment of prescribed norms such as application fee etc. applicable to them. But regarding counting in general level, as per date: 29-01-2000 and date: 23-07-2004 of General Administration Department, the instructions have to be followed and the existing instructions regarding the roster of the Government have to be followed from time to time.
- (3) In promotion if reserve level candidates are not available in the feeder cadre, the vacancy will have to be filled by direct recruitment and the proportion will have to be maintained.
- (4) Recruitment / promotion procedure has to be done as per the roster numbers prescribed by the Government.
- (5) Organizing short term coaching classes to prepare candidates for staff recruitment, competitive examinations.
- (6) There must be 1 representative of Scheduled Caste / Scheduled Tribe in the selection committee.

### **Hostel admission:-**

- (1) Admission as prescribed.
- (2) No rent will be charged from Scheduled Caste / Scheduled Tribe students.

### **Staff Quarters :-**

- (1) Allocation as prescribed

An officer at the level of Deputy Registrar has been appointed for the coordination, control and implementation of operations at all the Universities. In order to implement the reservation policy, an advisory committee will have to be formed at each college level in place of the chairperson of the principal of that college. Whose structure is as follows. Committee meeting to be called in every 3 months. To review the action taken in the previous meetings in that meeting. To review the reservation policy prescribed by the Central Government and the State Government in that college / institution and to maintain the standard in the matter of student admission / staff recruitment. Control, implementation will have to be done. The formation and action of the committee will have to be reported to the SC-ST cell of the University here.

### **Advisory Committee at the College:-**

- (1) Principal / Head of the concerned organization
- (2) Two to four academic staff-members(including members of Scheduled Castes / Scheduled Tribes)
- (3) A- District Backward Classes Welfare Officer of the concerned district  
B-Vigilance Officer, Tribal Welfare } **Representative of the Government**
- (4) Deputy Registrar, Representative of SC-ST Cell-University's Representative.  
A copy of the guideline issued by the University Grants Commission regarding the implementation of the reserve policy is also included in the implementation sense, for which all Universities are informed to do for strict implementation.


All Universities under the Department of Education are directed to amend the applicable Statutes / Ordinances / Regulations or Rules of the University or to introduce the provisions of this Circular by following the rules as per the instructions of the Circular presented in the competent authorities of the University.

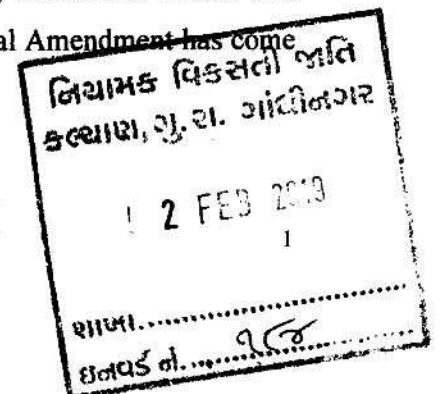

**Preamble**

Whereas at present under Articles-15 and 16, Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes/Other Backward Classes are availing the constitutional benefit of reservation in the admission to the educational institutions, including private educational institutions, whether aided or unaided, and reservation in the civil posts and services also under the Gujarat State in the ratio of 7% for Scheduled Castes, 15% for Scheduled Tribes and 27% for Socially and Educationally Backward Classes / Other Backward Classes.

And Whereas Parliament of India, vide the Constitution (One Hundred and Third Amendment) Act-2019, has amended the Articles-15 and, 16 and provisions have been made for reservation in admission in educational institutions and appointments in civil posts and services under State in favour of Economically Weaker Sections of citizens in addition to the existing categories such as Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes. This Constitutional Amendment has come into force with effect from dt. 14/1/2019.

And therefore now Gujarat State is empowered under Part-III of the Constitution of India to make special provisions for reservations in favour of persons who are not covered under the existing scheme of reservation for Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes, hence the following resolution is passed.

### **Resolution**


1. There shall be 10% reservation in favour of Economically Weaker Sections(EWSs) of citizens / persons who are not covered under the existing scheme of reservation for Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes, in the admissions to the educational institutions, including private educational institutions, whether aided or unaided, as prevalent at present, and in the appointments in civil posts and services under the State of Gujarat. This reservation in educational institutions would not apply to the minority educational institutions referred to in clause (1) of Article-30 of the Constitution of India.
2. This 10% reservation shall be in addition to the existing reservation of 7%, 15% and 27% respectively for Scheduled Castes, Scheduled Tribes, and Socially and Educationally Backward Classes.
3. The eligibility criteria for identification of the Economically Weaker Sections of the citizens/persons shall be as under :

Persons whose annual family income is less than Rs. 8.00 lakhs are to be identified as EWSs. Family, for this purpose, will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application.

4. Certificates for eligibility for reservation in favour of Economically Weaker Sections of citizens shall be in the format as prescribed. Competent authorities to issue such certificates for the reservation under the State Government shall be as under :

- (1) District Magistrate/Additional District Magistrate/Collector/Additional Collector/Dy. Collector / Asst. Collector

- (2) Revenue officers not below the rank of the Mamlatdar / Tehsildar
  - (3) Taluka Vikas Adhikari (TDO)
  - (4) District Dy. Director, (Developing Caste Welfare) / Social Welfare Officer (Developing Caste Welfare)
  - (5) It is clarified here that, for the reservation under Central Government the Competent authorities for issuing Certificates for eligibility shall be Officers not below the rank of Tehsildar/Mamlatdar.
5. When eligibility certificate in favour of Economically Weaker Sections of citizens is denied by the certificate issuing authority or when such certificate is found to be issued wrongly, the appellate authorities and procedure shall be as under :
- (1) Where the decision is taken by the Mamlatdar /Tehsildar/ Taluka Development Officer / Dy. Director (Developing Caste Welfare)/ Social Welfare Officer (Developing Caste Welfare), the appellate authority shall be the Prant Officer / Dy. Collector / Asst. Collector.
  - (2) Where the decision is taken by the Additional Collector/Prant Officer / Dy. Collector / Asst.Collector, the Appellate authority shall be Collector.
  - (3) Where the decision is taken by the Collector, the appellate authority shall be the State Level Scrutiny Committee.
  - (4) The appellate authorities shall dispose the appeals before them as far as possible within 30 days from the receipt of such appeals.
  - (5) The record being created while issuing the eligibility certificates and disposing the appeals shall be maintained permanently.
6. This 10% reservation policy introduced by Gujarat State shall be applicable for the admissions and appointments under Gujarat State and shall be available to the original inhabitant of Gujarat State i.e. those who have been permanently settled in Gujarat State on or prior to 1-4-1978.
7. Thirty three percent of posts from within 10% quota shall be further sub-reserved for women belonging to the same Economically Weaker Sections.
8. This resolution has come into force with effect from Dt.14-01-2019. General Administrative Department and other concerned nodal administrative departments such as Education Department, Health and Family Welfare Department etc. shall have to issue necessary further detailed resolutions, orders and circulars to facilitate the implementation of this policy of 10% reservation, while keeping in mind, where it is required, the guidelines issued by Government of India





**Gujarat Professional Technical Educational Colleges or institutions (Regulation of Admission and Fixation of Fees) Act, 2007**

**No.GH/SH/21/2020/PVS/102020/13/S:** - In exercise of the powers of conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to regulate admission to the Bachelor of Engineering and Technology and payment of fees, as follows, namely: -

1. **Short Title and Commencement.** - (1) These rules may be called the Bachelor of Engineering and Technology (Regulation of Admission and Payment of Fees) Rules, 2020.
- (2) They shall come into force on the date of their publication in the *Official Gazette*.
2. **Definitions.** - (1) In these rules, unless the context otherwise requires, -
  - (a) "Act" means the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008);
  - (b) "Admission" for the purpose of these rules means admission of candidates in the Bachelor of Engineering and Technology courses;
  - (c) "Course" means one of the branches of learning in program which will include dual degree course and integrated course;
  - (d) "Engineering Branch" means various branches of Engineering and Technology in the professional educational colleges or institutions of the State;
  - (e) "Engineering Courses" means the Bachelor of Engineering and Technology in the Professional Educational Colleges or Institutions of the State;

- (2) A candidate seeking admission on reserved seat shall be required to produce a Certificate of Caste :

Provided that the candidates belonging to the Socially and Educationally Backward Classes shall be required to produce a certificate to the effect of non-inclusion in Creamy Layer in addition to the caste certificate.

- (3) No caste certificate shall be valid unless it is duly stamped, signed and issued by the competent authority as specified by the State Government.
- (4) No certificate to the effect of non-inclusion in Creamy Layer shall be valid, unless it is duly stamped, signed and issued by the competent authority specified by the State Government. Such certificate shall have validity as per prevailing Rules of the State Government.
- (5) If a candidate fails to submit the certificates as required under sub-rule (2) within the stipulated time, his candidature shall be considered for admission under unreserved category.
- (6) If a candidate of reserved category gets admission on unreserved seat in order of merits, he may be given admission on the unreserved seat according to his preference.
- (7) The admission of a candidate of a reserved category on a reserved seat shall be valid subject to the verification of caste certificate issued to him by the competent authority as specified by the State Government in this behalf. In case the caste certificate is found to be invalid on verification, he shall not have right to claim his admission on reserved seat and if he has already been granted admission, such admission shall be cancelled. Admission of such candidate may be continued in case of availability of vacant unreserved seats, subject to the condition of eligibility of merit.
- (8) After granting admission to all the candidates of reserved categories on respective reserved seats, the reserved category seats remaining vacant shall be transferred to the unreserved category seats.

**7. Reservation for Physically Disabled Candidates. -**

Five percent. of the available seats in each category shall be reserved, in accordance with the provisions of the section 32 of the Rights of Persons with Disabilities Act, 2016 (49 of 2016) for the persons with benchmark disability who can perform the academic activities in the respective course. A candidate with disability shall have to submit certificate of disability issued and duly signed by the certifying authority.

**Explanation.** - "person with disability" means a person suffering from not less than forty percent. of any disability as certified by a competent medical authority.

**8. Reservation for the Children of Defence Personnel and Ex-Servicemen. -**

- (1) One percent. of available seats shall be reserved for the children of Defence personnel and Ex-Servicemen. for admission of Gujarat origin or serving in Gujarat.
- (2) A candidate claiming admission against the Ex-Serviceman category shall required to submit a certificate to that effect duly issued by the Director, Sainik Welfare Board, Gujarat State or by the District Sainik Welfare Officer. In-Service Defence Persons / retired defence persons notified by the Ministry of Home Affairs, Police Division-II, Government of India shall require to submit certificate to that effect duly issued by the commanding officer of the respective unit in which they are serving or were serving just before the retirement respectively.
- (3) The seats remaining vacant against the category of Defence Personnel and Ex-Servicemen shall be filled up from the merit list of unreserved category candidates.
- (4) The children of Defence Personnel/Ex-Servicemen of Gujarat origin and children of defence personnel serving in Gujarat shall be included under the reserved category

SPECIAL PROVISIONS FOR PERSONS WITH BENCHMARK DISABILITIES

**31. Free education for children with benchmark disabilities.**—(1) Notwithstanding anything contained in the Rights of Children to Free and Compulsory Education Act, 2009 (35 of 2009), every child with benchmark disability between the age of six to eighteen years shall have the right to free education in a neighbourhood school, or in a special school, of his choice.

(2) The appropriate Government and local authorities shall ensure that every child with benchmark disability has access to free education in an appropriate environment till he attains the age of eighteen years.

**32. Reservation in higher educational institutions.**—(1) All Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than five per cent. seats for persons with benchmark disabilities.

(2) The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions of higher education.

**33. Identification of posts for reservation.**—The appropriate Government shall—

(i) identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34;

(ii) constitute an expert committee with representation of persons with benchmark disabilities for identification of such posts; and

(iii) undertake periodic review of the identified posts at an interval not exceeding three years.

**34. Reservation.**—(1) Every appropriate Government shall appoint in every Government establishment, not less than four per cent. of the total number of vacancies in the cadre strength in each group of posts meant to be filled with persons with benchmark disabilities of which, one per cent. each shall be reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one per cent. for persons with benchmark disabilities under clauses (d) and (e), namely:—

(a) blindness and low vision;

(b) deaf and hard of hearing;

(c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;

(d) autism, intellectual disability, specific learning disability and mental illness;

(e) multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities:

Provided that the reservation in promotion shall be in accordance with such instructions as are issued by the appropriate Government from time to time:

Provided further that the appropriate Government, in consultation with the Chief Commissioner or the State Commissioner, as the case may be, may, having regard to the type of work carried out in any Government establishment, by notification and subject to such conditions, if any, as may be specified in such notifications exempt any Government establishment from the provisions of this section.

(2) Where in any recruitment year any vacancy cannot be filled up due to non-availability of a suitable person with benchmark disability or for any other sufficient reasons, such vacancy shall be carried forward in the succeeding recruitment year and if in the succeeding recruitment year also suitable person with benchmark disability is not available, it may first be filled by interchange among the five categories and only when there is no person with disability available for the post in that year, the employer shall fill up the vacancy by appointment of a person, other than a person with disability:

Provided that if the nature of vacancies in an establishment is such that a given category of person cannot be employed, the vacancies may be interchanged among the five categories with the prior approval of the appropriate Government.


